ADVERTISEMENT NOTICE

Subject:- Operational Guidelines for Registration and Renewal of Child Care Institutions.

The Government of Jammu and Kashmir has passed Jammu and Kashmir Juvenile Justice (Care & Protection of Children) Act, 2013 and the Operational Guidelines for Registration and Renewal of Child Care Institutions has been adopted vide Government Order No. 74-SW of 2016 Dated:- 15.03.2016. under Rule 66 of Jammu and Kashmir Juvenile Justice (Care & Protection of Children) Rule, 2014. Every Child Care Institution run by NGO or Government shall have to get themselves registered under Jammu and Kashmir Juvenile Justice (Care & Protection of Children), Act 2013.

All such institutions shall make an application together with a copy each of rules, byelaws, memorandum of association, list of governing body, office bearers, balance sheet of past three years, statement of past record of social or public service provided by the institution or organization to the Government. After verifying the facts from the institutions or organization to take the care and protection of children, health, education, boarding and lodging facilities, vocational facilities and scope of rehabilitation, may issue a registration certificate to such organization under section 35 of the Act.

It is, therefore, mandatory to register all the child care Institutions (CCIs) housing children under the Jammu & Kashmir Juvenile Justice (Care & protection of Children) Act/Rules, 2013/14. The powers of registration stand delegated to Director, Social Welfare Kashmir/Jammu, vide Government Order No. 96-SWD of 2015 dated:- 04.06.2015 within their respective jurisdictions.
