**Notification for Pre-matric/Post matric/Merit-cum-Means Scholarship for students belonging to the notified Minority Communities for the year 2016-17.**

Pre-matric/Post-Matric/Merit-cum-Means Scholarship for students belonging to the notified Minority Communities (Muslims, Sikhs, Christians, Buddhists, Parsis, Jains) scholarships are awarded to the students for studies in India in a Government or Private School from the notified minority communities who have secured **not less than 50% marks** or equivalent grade in the previous final examination and the annual income of whose parents/guardian **from all sources do not exceed Rs. 1.00 lakh under Pre-Matric Scholarship, Rs. 2.00 lacs under Post-Matric scholarship & Rs. 2.50 lacs under Merit-cum-Means Scholarship.**

From 2016-17, the online implementation of the Pre-Matric/Post-Matric/Merit-cum-Means Scholarship Scheme will be done through the common National Scholarship Web Portal (NSP 2.0) of the Government of India, under URL [www.scholarships.gov.in](http://www.scholarships.gov.in). A link to the site is also made available in the website of this Ministry i.e. [www.minorityaffairs.gov.in](http://www.minorityaffairs.gov.in). **Only Online applications under the Pre-matric/ Post-Matric/ Merit-cum-Means Scholarship will be accepted and no request for Offline applications will be entertained. It may be noted that submission of Aadhaar is mandatory.**



3.	Submission of Online applications for Fresh/Renewal scholarship by students for higher education like ITIs, Diploma, B.Ed. M. Phil. & Ph.D etc under Post-Matric Scholarship.	15 <sup>th</sup> July to 31 <sup>st</sup> October 2016	
4.	Submission of Online applications for Fresh/Renewal scholarship by students under Merit-cum-Means Scholarship.	15 <sup>th</sup> July to 31 <sup>st</sup> October 2016
